

BINDING SERVICE ORDER – RENTAL OF OFF-ROAD OR ROAD SCOOTER
Pursuant to Section 2321 et seq. of Act No. 89/2012 Coll., the Civil Code

TMR Ještěd a.s., ID No.: 06080413, registered office: Jablonecká 41/27, 460 05 Liberec (hereinafter referred to as the “**Lessor**”) and

....., date of birth:, permanent address:
(hereinafter referred to as the “**Lessee**”) concluded on the date, month, and year stated below, pursuant to Section 2321 et seq. of Act No. 89/2012 Coll., the Civil Code, this vehicle rental agreement:

I.

1. By this agreement, the Lessor undertakes to provide the Lessee with temporary use of one or more off-road or road scooters (hereinafter referred to as the “ **Scooter**”), identified by the Lessor's registration number as stated on the tax document, for the purpose of downhill riding on the designated routes upper station Skalka – lower station Skalka or Ještěd Transmitter or Infocentre. The Lessor shall also equip the Lessee with protective gear such as a helmet.
2. The Lessor declares that the Scooter is fit for use as specified in this agreement and has no defects that would prevent its rental.

II.

1. The rental fee is agreed for a fixed period as follows:
 - **FUN TICKET for 2.5 hours** – according to the current price list (1 rental for 2.5 hours of one scooter + 1 chairlift ride uphill – last rental at 15:00)
 - **Scooter only for 2.5 hours from Horní Skalka** – according to the current price list (1 rental for 2.5 hours of one scooter – last rental at 15:00)
 - **Scooter only for 30 minutes from Ještěd Transmitter** – according to the current price list (1 rental for 30 minutes of one scooter – last rental at 16:30)

III.

1. The Lessee undertakes to pay the Lessor the rental fee at the time of signing this agreement, based on the applicable price list and rental duration. The rates are set out in the price list with which the Lessee has been acquainted and which the Lessee confirms by signature.
2. By signing this agreement, the Lessee agrees to pay a contractual penalty in case of exceeding the agreed rental time as follows:
 - **ADULT: CZK 190 for each scooter returned after the agreed time**
 - **SENIOR/JUNIOR: CZK 190 for each scooter returned after the agreed time**
 - **CHILD: CZK 190 for each scooter returned after the agreed time**
3. A scooter may be rented only upon presentation of valid personal identification.
4. Upon receipt of the scooter, the Lessee is obliged to inspect its condition.
5. The Lessee is required to familiarize themselves with and comply with the Operating Rules of the Scooter Rental.
6. The Lessee is obliged to use the scooter solely for the agreed purpose and to handle it in a way that prevents damage.
7. The Lessee is not permitted to allow any other legal or natural person to use the scooter.

IV.

1. Upon completion of the rental, the Lessee is obliged to return the scooter to the Lessor at the designated location. The Lessee is liable for any damage caused to the scooter by themselves or by persons to whom they granted access.

V.

1. This agreement shall become valid and effective upon the signature of both contracting parties and is executed in two counterparts. Each party shall receive one counterpart. By signing the agreement, the Lessee confirms that they have been acquainted with the Operating Rules of the Scooter Rental and the General Terms and Conditions of the Operator's Rental Service.
