

Operating Rules

Definition of Terms:

Kooperativa Funpark (hereinafter referred to as "Funpark") is a designated area for ski and snowboard lessons organized by Ještěd SKI SCHOOL. It may also be used by paying members of the public.

1. Funpark Opening Hours:

1. Opening hours for paying members of the public are daily from 8:30 AM to 4:00 PM.
2. At other times, the Funpark is reserved exclusively for the needs of TMR Ještěd a.s.

2. Age of Funpark Visitors:

1. The Funpark is open to visitors of all ages.

3. Entry to the Funpark:

1. Entry is permitted only through the turnstile, either accompanied by a JEŠTĚD SKI SCHOOL instructor or independently after paying the entrance fee. Visitors under 18 must be supervised by an adult.
2. The Funpark has a capacity of 50 children. This may be increased, but TMR Ještěd a.s. reserves the right to deny entry above this limit for safety reasons.
3. In case of high demand for JEŠTĚD SKI SCHOOL services, TMR Ještěd a.s. reserves the right to deny access to unaccompanied clients.
4. In the interest of all visitors, TMR Ještěd a.s. also reserves the right to refuse children with infectious illnesses, including runny noses, coughs, diarrhea, or other symptoms. Allergies and chronic conditions must be reported during check-in for the child's safety. If Funpark staff are aware of health issues, they can respond individually. These records may help trace the origin of infections or outbreaks and can only be shared with health authorities upon request.
5. Persons (children or their escorts) showing clinical symptoms of COVID-19 are prohibited from using the Funpark.
6. Entry is not permitted without ski or snowboard equipment. Walking inside the Funpark without skis attached to boots is not allowed.

4. Child Pick-Up:

1. Children will be handed over after their lesson at JEŠTĚD SKI SCHOOL. If a different person will collect the child, this must be reported during check-in. This person must be at least 18 years old.

5. Personal Belongings:

1. TMR Ještěd a.s. is not responsible for any damage to or loss of valuables brought into the Funpark.

6. Rules of Conduct in the Funpark:

1. Sledding, tobogganing, and moving without ski or snowboard gear are prohibited.

2. Visitors must always follow instructions from Funpark staff (instructors, lift operators).
3. It is forbidden to bring sharp objects, food, drinks, or pets into the Funpark, and to smoke or consume alcohol.
4. If children/visitors behave contrary to the operating rules or do not follow staff instructions, the staff will contact the child's guardian to pick them up immediately. These children will not be allowed further access. This especially applies in cases of conflict-causing or aggressive behavior. Guardians must stay nearby and be reachable by phone at all times during their child's stay in the Funpark.
5. Photography for professional or press purposes by third parties other than TMR Ještěd a.s. staff is not permitted.
6. If public health regulations require face masks, accompanying persons must wear a respirator. Funpark staff are authorized to enforce this.
7. The public may use educational elements installed in the Funpark, unless otherwise decided by TMR Ještěd a.s. These elements must be used only for their intended purpose without causing damage or injury. TMR Ještěd a.s. is not liable for injuries or damage resulting from their use.
8. Conveyor belts may only be operated by trained employees of TMR Ještěd a.s.

7. Funpark Staff and Safety:

1. Safety is ensured by qualified personnel with appropriate training and experience.
2. The Ještěd SKI SCHOOL office is equipped with a first-aid kit. In the event of an injury, staff will provide basic care or call mountain or emergency rescue services.

8. Ski Lifts and Conveyor Belts:

1. The transport conditions for lifts and conveyor belts in the Funpark are governed by the General Transport Terms and Contractual Transport Conditions available at <https://www.skijested.cz>.
